	1) The underlying assets of these funds are a mix of arbitrage funds and debt funds, primarily corporate bond funds.			
	2) These funds offer significant tax advantages, being taxed at 12.5% after a holding period of two years, unlike liquid or pure debt funds which are taxed as per the investor's income slab.			
	3) With around 60% of the portfolio invested in debt categories like corporate bond funds, the expected returns are 60–90 basis points higher than those of traditional liquid
